

# First Business Expansion into Canada

- Establishment of Local Subsidiary and Participation in a157-Unit Condominium Project

Hankyu Hanshin Properties Corp. is pleased to announce its first business expansion into Canada.

Specifically, we will participate in Claystone Project (hereinafter the "Project") in the Greater Toronto area\*, in collaboration with Canadian real estate developer Graywood Developments. To facilitate this, we have established Hankyu Hanshin Properties Canada Corp., a local subsidiary through which we will promote the Project.

The Project is a seven-story condominium development consisting of 157 units, located approximately 40 km southwest of downtown Toronto, in the town of Oakville. The area offers high living convenience with numerous commercial and educational facilities nearby, as well as access to rich natural environments like Lake Ontario (one of the Great Lakes near the U.S.-Canada border) and many parks. These advantages are expected to attract residential demand from not only Oakville residents but also people working in downtown Toronto and nearby facilities.

With the addition of this Project, our overseas housing business now expands across a total of seven countries (refer to the next page for the list of countries).
